Thiess-Khishig Arvin Joint Venture secures three-year mining services contract at Oyu Tolgoi, Mongolia

The Thiess-Khishig Arvin Joint Venture (TKAJV) has secured a new contract to provide mining services at the world-renowned Oyu Tolgoi copper and gold project in Mongolia. This milestone is significant as it will see TKAJV return to underground mining services, building on its recent successes with numerous underground construction projects, following the development of the 6.5km twin declines.

The scope of work for the three-year contract includes executing underground ground support and development work, utilising more than 300 Thiess people to undertake these works.
