Case study

INDIGENOUS ENGAGEMENT AND PARTNERSHIP

In 2023, Thiess was engaged by a major mining company to conduct a pre-feasibility study and tender submissions for their brownfield developments in Canada.

A critical component of these was the development of an Indigenous Participation Plan. To align with a mutual commitment to free, prior and informed consent, we worked with our client to consult with the First Nations communities on the plan.

Over twelve months, Thiess engaged with the local First Nations communities and businesses, through consultation with the community administration leadership, presenting at Chief and Council meetings, and participating in on-Territory cultural experiences.

Thiess worked proactively to understand the interests, expectations, risks and opportunities of the local communities, and how we could work in partnership with them to support sustainable community development through employment, procurement and social investment.

This resulted in Thiess securing a load and haul contract. Critical to this contract delivery is participation of the First Nations communities and their business entities. First Nations owned business are providing crushing and drill services, representing 25% of the total project contract value.
