By registering through the Thiess website, your company name will be entered into the Thiess database and reviewed when Thiess next goes to market for that category of work. Thiess independently schedules sourcing based on demand or changes to the market.

Contract requirements

To enlist a supplier Thiess is required to:

- Obtain three quotes for all procurement activities
- Generate a contract for all subcontracted and servicing works
- A purchase order will need to be raised for goods valued under \$20,000.

Pre-qualification

To progress from registration to pre-qualification suppliers of goods and services will be asked to complete Thiess' Third-Party Anti-Bribery, Corruption and Business Integrity Declaration form.

Depending on the category and scope of work to be delivered, suppliers of goods and services may also need to provide information about other management systems including health, safety, quality, environment and where relevant proof of insurances.

Thiess requires all suppliers to provide both an ABN and ACN.

Insurance

If the category of work involves providing advice, direction or design, then professional indemnity insurance is required.

Thiess requires all suppliers of services to have public liability and products liability insurance with a minimum cover of \$20 million.

Works Compensation Insurance is required by law if providing services.

Systems

If a supplier does not have its own certified internal systems and the work undertaken requires quality system or health and safety system documentation, the supplier will need to complete Thiess' documentation.

Procurement Process

Step 1: Suppliers register interest at thiess.com

Step 2: Thiess determines:

- scope of work and evaluation criteria
- relevant businesses
- procurement activity i.e. Invitation to tender or request for quotation and, conducts pre-qualification process

Step 3: Suppliers respond to procurement activity which may require the following documentation:

- Environment
- Health and Safety
- Quality
- Human and Industrial Relations
- Insurances

Step 5: Thiess evaluates submissions against pre-determined evaluation criteria and awards the work.

Thiess will provide post-tender feedback to successful and unsuccessful suppliers upon request.
